Administrative History

The office of the president was created in 1870 with the founding of St. Ignatius College. Arnold Dame, S.J., served as the first president from 1870 to 1872. Twenty-three Jesuits have served as president of Loyola during its history, the first twelve presidents serving under the title of president of St. Ignatius College before the college was re-chartered as Loyola University in 1909. Alexander J. Burrowes, S.J., was the last president of St. Ignatius College and the first president of Loyola University.

Raymond C. Baumhart, S.J., was inaugurated as the twenty-first president of Loyola University Chicago in 1970 and was the longest serving president of Loyola to-date, retiring in 1993. His tenure saw the university grow in both enrollment and physical space.

Scope and Content

Records span the years 1976 to 1984 and include budget reports, correspondence, and committee minutes. Subjects include the Loyola University Medical Center and strategic planning.
