Biographical Sketch

Professor Joseph A. Gagliano joined the Loyola History Department faculty in 1962. His scholarship focused on Latin American History and politics, and the Church in Latin America. He participated in many regional, national, and international conferences on Latin America and published numerous articles and books on that topic. Many of these works, as with his conference presentations, discussed economics and politics as crucial aspects of the Coca industry's history. In 1992, Loyola hosted the NEH funded symposium "Agents of Change: The Jesuits and Encounters of Two Worlds," largely due to Gagliano's efforts. While at Loyola, Gagliano served in a variety of leadership positions including as the Graduate School Associate Dean, 1976 to 1986; Graduate

School Acting Dean, 1985; History Department Chair, 1986 to 1995; and Classical Studies Acting Chair, 1996. He received honors including the 1996 Loyola Faculty Member of the Year and graduating seniors consistently identified him as one of their three most effective teachers. Gagliano retired from teaching full time in 1997, assuming the title of Professor Emeritus at Loyola. Dr. Gagliano passed away in 2011.

Scope and Content

The Joseph A. Gagliano, Ph.D., papers comprise 3 linear feet spanning the years 1920 to 1997, with the bulk being from the late 1960s to 1996 and reflect Gagliano's administrative work within the university, his interest in Latin American, and organizations he was involved in outside of his academic duties at Loyola. The papers include memos, agendas, handouts, brochures, flyers, correspondence, statistics, symposium papers, reports, evaluations, strategic plans, and publications. Topics include the Agents of Change symposium, Jesuits, Latin America, Loyola University Chicago, minorities, accreditation, and student strike.
