Biographical Sketch

George G. Kaufman was born in 1933 in Berlin, Germany. When he was three years old, his family moved to Amsterdam in the Netherlands, then to New York City when he was seven. They settled in Manhattan, where he attended public schools.

Kaufman earned his B.A. in Physics from Oberlin College in 1954, and his M.A. in Economics from the University of Michigan in 1954. After completing his Master's degree, he served twenty-one months in the U.S. Navy, visiting the Mediterranean, Caribbean, and Greenland during his tour of duty. He was allowed to end his two-year enlistment three months early out of his two-year enlistment in order to attend the University of Iowa, where he earned his Ph.D. in economics in 1962.

In 1959, while still working on his Ph.D., Kaufman began a research fellowship with the Federal Reserve Bank of Chicago. He was hired as a full time research economist upon completion of his Ph.D. In 1970, he began teaching at the University of Oregon, where he was the John B. Rogers Professor of Banking and Finance for ten years. While there, he taught at the University of California-Berkeley and Stanford University, while on leave of absence. He also served as the Deputy to Assistant Secretary for Economic Policy at the U.S. Treasury Department from August-December 1976.

In 1981, Dr. Kaufman returned to Chicago where he accepted the John F. Smith Professor of Finance and Economics endowed chair at Loyola University Chicago and worked as a consultant for the Federal Reserve Bank of Chicago. Dr. Kaufman also spent traveling to Washington, D.C., where he delivered statements before Congress. In 2004, he spent a year working at the Reserve Bank of New Zealand.

In addition to his endowed chair position, Dr. Kaufman served as Director of the Center for Financial and Policy Studies at Loyola's School of Business. The Center's primary function was to host finance and policy symposiums, and host seminars given by faculty from other universities. At Loyola, Dr. Kaufman served as the first chairman for the rank and tenure committee, the Research Committee within the School of Business administration, and the Graduate Curriculum Committee and the University Investment Committee.

Dr. Kaufman was very involved in public policy and financial regulation, cofounding the Shadow Financial Regulatory Committee in 1986. Comprised of academic and professional economists, the Shadow Financial Regulatory Committee analyzed the financial services industry from a public interest and public safety perspective. Its primary focus was on regulation of the financial services industry, with the goal of helping improve the efficiency and safety of financial systems. The Committee's greatest contribution to public policy was the development of a program to create a safer regulatory structure. Congress accepted this program and implemented it as a major part of the Federal Deposit Insurance Corporation Improvement Act of 1991.

Dr. Kaufman delivered over a dozen statements before various committees of the United States Congress, including statements related to the failure of Superior Bank FSB in Hinsdale, Illinois. In 1992 Dr. Kaufman founded the Financial Economists Roundtable, which gathered senior members of the field who had made contributions to the discipline to meet annually to discuss policy issues. He co-founded two academic journals: *Journal for Financial Services Research* and *Journal of Financial Stability*, and served as President of four professional organizations: Western Economic Association, American Finance Association, Midwest Finance Association, and the North American Economics and Finance Association.

Dr. Kaufman retired from Loyola and was named a Professor Emeritus in December 2016.

Scope and Content

The George G. Kaufman, Ph.D., papers consist of 61.63 linear feet spanning the years 1963-2017 and include academic journals, articles, books, opinion editorials, book reviews, presentation transparencies and slides, drafts, notes, class materials, correspondence, meeting agendas and minutes, photographs, cassette and VHS tapes, an

Series

Series 1: Loyola Materials, 2003-2017, Undated. Boxes 1-2.

Series 1 contains papers related to Dr. Kaufman's work as the John F. Smith Professor of Economics and Finance at Loyola University Chicago. These records include course notes, slides, exams, homework, and quizzes, departmental correspondence, and business cards. This series is divided into three subseries:

Subseries 1A: Class Materials, c. 2010s-2015, Undated, Boxes 1-2

Contains lecture notes, blank exams and quizzes, answer keys, homework assignments, handouts, and slides for Finance 451 and Finance 337.

Subseries 1B: Office and Department Correspondence, 2003-2017, Box 2

Contains a list of Center for Financial and Policy Studies symposia, comments on proposals for a talk, and correspondence regarding Dr. Kaufman's retirement.

Subseries 1C: Business Cards, Undated, Box 2

Contains multiple styles of Dr. Kaufman's Loyola University Chicago business cards.

Series 2: Kaufman Publications and Papers, 1963-2017. Boxes 3-56.

Series 2 contains materials related to Dr. Kaufman's publications spanning the years 1963-2017. These materials include drafts, notes, comments, related correspondence, final drafts, proofs, and published copies. Many of these publications were co-authored with other economists and finance professionals. Topics include monetary policy, duration rates, bank runs, systemic risk, bank regulation, Federal Reserve Bank, deposit insurance, Federal Deposit Insurance Corporation, Savings and Loan Crisis, Too-Big-to-Fail, 2007 financial crisis, financial stability, cross-border banking, asset bubbles, and Basel II.

Various publication formats include academic journals, non-profit think tank publications, books, book chapters, newspaper articles, and an IBM computer program. This series is divided into seven subseries:

Subseries 2A: Articles, 1963-2016, Boxes 3-45

Contains drafts, notes, comments, correspondence, related research, and published copies.

Subseries 2B: Book Chapters, 1986-2015, Boxes 45-52

Contains drafts, notes, comments, correspondence, related research, and scans of chapters in published book.

Subseries 2C: Books, Pamphlets, and Unpublished Papers, 1977-2017, Boxes 52-54

Contains drafts, notes, comments, correspondence, research for published pamphlets and small books, as well as for unpublished material. A letter from Dr. Anna Schwartz also appears.

Subseries 2D: Publishing Contracts and Royalty Statements, 1970-2015, Box 54

Contains publishing contracts and royalty statements for several of Dr. Kaufman's books.

Subseries 2E: Opinion Editorials, 1984-2013, Boxes 54-55

Contains drafts, notes, correspondence, and published copies of opinion editorials written by Dr. Kaufman and published in various newspapers and journals, such as *The Wall Street Journal*, *Chicago Tribune*, and *American Banker*. Topics include banking, bank runs, Basel II, deposit insurance, and the 2007 financial crisis.

Subseries 2F: Book Reviews, 1966-2014, Box 55

Contains book reviews Dr. Kaufman wrote for academic journals.

Subseries 2G: Computer Programs, 1984-1989, Box 56

Contains a paper about a computer program on bank interest rate risk management that Dr. Kaufman developed with G. O. Bierwag. This subseries also contains the IBM disks for the second version of that computer program.

Series 3: Shadow Financial Regulatory Committee (SFRC), 1985-2017. Boxes 56-85.

Series 3 contains materials related to the Shadow Financial Regulatory Committee (SFRC), which Dr. Kaufman co-founded in 1986. The purpose of the committee was to analyze and comment upon developments in the financial services industry, study current issues in that industry, provide recommendations for appropriate legislative or regulatory responses, and comment on public finance policy issues. The group was comprised of academic finance and economics professionals who met quarterly between 1986 and 2015, when the group ceased operations. The American Enterprise Institute (AEI) funded SFRC operation between 1998 and 2015, although the committee remained an independent policy group and did not speak on behalf of AEI. Dr. Kaufman served as co-chairman of the SFRC for the entirety of its existence. Beginning in the 1990s, several international SFRCs formed around the world, including Europe, Japan, Asia, Australia-New Zealand, and Latin America. Records related to the SFRC are arranged in five subseries:

Subseries 3A: U.S. Shadow Financial Regulatory Committee Meetings, 1986-2015, Boxes 56-71

Contains materials organized by meeting. Materials include correspondence, meeting minutes, policy statements, preliminary meeting agendas, final meeting agendas, and notes. This subseries is arranged with Dr. Kaufman's meeting files preserved chronologically. At the end of the subseries, extra copies of meeting agendas, minutes, and correspondence appear in chronological order.

Subseries 3B: Joint International Shadow Financial Regulatory Committee, 1997-2016, Boxes 71-75

Contains materials related to Joint International SFRC meetings, including correspondence, minutes, and policy statements. This subseries also contains records pertaining to a private grant the SFRC received from the Smith Richardson Foundation to support joint international meetings.

Subseries 3C: Shadow Financial Regulatory Committee Publications, 1986-2016, Boxes 75-81

Contains US SFRC policy statements, journal articles written by members about the committee, and books written jointly by committee members about pressing public policy issues.

Subseries 3D: Shadow Financial Regulatory Committee Administrative Documents, 1985-2015, Boxes 81-84

Contains documents and correspondence related to the founding of the SFRC, by-laws, annual reports, and 501(c)3 tax information.

Subseries 3E: Shadow Financial Regulatory Committee Presentations, 1989-2017, Boxes 84-85

Contains records related to presentations about the committee given by SFRC members at various conferences and professional meetings.

Series 4: Federal Reserve Bank, 1963-2016. Boxes 85-100.

Series 4 contains articles, papers, and presentations Dr. Kaufman wrote and gave for various Federal Reserve Bank branches over the course of his career. Topics include banking, regulation, deregulation, Savings and Loan crisis, mortgage lending, bank contagion, monetary policy, deposit insurance, and asset bubbles. This series is divided into four subseries:
