Biographical Sketch

John F. O'Keefe (1904-1992) served as the private secretary of Samuel Insull between the years of 1925 and 1932, and as the executive secretary of Insull Utility Investments, Inc. until its collapse in 1932. In addition to his work with Insull, O'Keefe became involved in publishing, serving as a publisher for the Chicago Daily News and as the executive director of the Chicago Newspaper Publishers Association from 1946 to 1972.

Scope and Content

The John O'Keefe papers comprise 0.5 linear feet spanning the years 1927 to 1939 and consist of correspondence and legal papers pertaining to Insull Utility Investments, Inc.

Series

Series 1: Correspondence, 1927-1939, Box 1

Correspondence is arranged by date and consists mainly of letters to O'Keefe from Samuel Insull.

Series 2: Legal Papers, ca. 1928-1934, undated Box 1

Legal papers include depositions, financial records, summaries of previous legal actions, earnings reports, memoranda, lists of investors and investments, auditor reports, legal
