Biography

Harold L. Platt was born in 1945. He graduated from the University of Illinois in 1967 and received his PhD. From Rice University in 1974. Dr. Platt taught at Houston Community College prior to joining the History faculty at Loyola University Chicago in 1974. He was an assistant professor from 1974 to 1981, an associate professor from 1981 to 1990 and professor from 1990 to 2012. In 2012, Dr. Platt was named professor emeritus. Dr. Platt's research focuses on urban history, in particular the growth of electricity and public utilities.

Scope and Content

The Harold L. Platt, PhD, papers span the years 1888 to 1988 (primarily 1907 to 1934) and consist of notes, reports, histories, and articles. These materials were gathered by Dr. Platt during research for his book *The Electric City* (1991).
