Biographical Sketch

A.G (Tassos) Malliaris was born on November 10, 1942 in Greece and was raised in Egypt before moving to the United States. Malliaris received his B.A. in Economics from the Athens School of Economics in 1965. Before beginning his graduate work Malliaris worked for the Industrial Planning Division of the Center of Planning and Economic Research from 1965-66 and on the World Bank Project for the Industrial Development of Greece in 1966 in Athens. He went on to receive a M.A in Economics in 1970 and a year later in 1971 he earned his Ph.D. in Economics both from the University of Oklahoma. Malliaris continued his education in the field of Mathematics earning a M.A. from the University of Oklahoma in 1972 and a Ph.D. in 1986 from the University of Chicago. During his time at Oklahoma, he served as a research assistant and began teaching courses in Economics and Mathematics.

Malliaris was then hired as an Assistant Professor of Economics in 1972 at Loyola University Chicago. He would become an Associate Professor of Economics in 1978 and eventually a Professor of Economics in 1982 and a Professor of Finance in 1998. Malliaris served as the Chair of the Department of Economics from 1974-1978 and was named the Walter F. Mullady, Sr. Professor in 1987. He has served as the Associate Dean and Director of The Graduate School of Business from 1977-89, on the Dean's Advisory Committee in 1995-97 and as Interim Dean of the School of Business Administration from 2004-05. Malliaris was named the Outstanding Faculty Member by the Graduate School of Business Alumni Association in 1977 and 1994. Malliaris was also named the Faculty Researcher of the Year by the School of Business Administration in 1999 and 2008. He has also taught many executive courses in Chicago, London, Rome, Milan, Athens, Vienna, Prague, Tokyo, Hong Kong, Beijing and Bangkok. Malliaris served as President of the North American Economics and Finance Association in 2001 and The Athenian Policy Forum since 2007. He also served as the President in 2011-12

and Chairman of the Board of Trustees from 2012-14 of The Multinational Finance Society. Malliaris has been named as an Editor or Associate Editor of the International Review of Financial Analysis, Multinational Finance Journal, Journal of Economic Asymmetries, European Research Studies, Frontiers in Finance and Economics, The University of Piraeus Journal of Business and International Journal of Portfolio Analysis and Management.

Scope and Content

The Tassos Malliaris Papers comprise 11.0 linear feet of records spanning the years 1970-2015 and consists of photographs, books and articles, correspondence, academic program books, and annual reports. It also includes his activities as the Mullady Chair, conferences he attended, and teaching activities both at Loyola and other universities. Languages included in the collections are English, Greek, Italian and German.

Series

Series 1: Loyola University Chicago – Mullady Chair, 1987-2013, Boxes 1-4

Contains materials related to Malliaris' time as the Walter F. Mullady, Sr. Professor of Economics and Finance an endowed chair within the Quinlan School of Business. It includes a program from a presidential inauguration for the university, an agreement between Loyola and the University of Piraeus for a joint program and the honorary degree awarded to Anna Schwartz as well as correspondence, inter-office memos, and documents related to conferences and lectures.

Series 2: Correspondence, 1971-2002, Box 4

This series contains correspondence to and from Jerome L. Stein about their collaboration on a book and continued communications. It also includes departmental correspondence for the business school.

Series 3: Teaching, 1974-2013, Boxes 4-7

Syllabi, exams, course outlines, and lecture notes relating to his courses at Loyola and as well as seminars and lectures given at other universities including the Athens University, Erasmus University, University of Tennessee, Lawrence University, Keio University, Indiana University and Northwestern University. Some items are in Greek or Italian.

Subseries 3A: Loyola University Chicago, 1974-2000, Boxes 4-5

This subseries contains syllabi, exam questions, and program books related to his courses taught for Loyola University Chicago at the Chicago campuses as well as in the Athens and Rome programs.

Subseries 3B: Seminars and Lectures, 1983-2013, Boxes 5-7

Contains course outlines, lecture notes and copies of lectures for seminars and lectures delivered in Milan, Ceram, Greece, Indiana University, Advantage Futures Series and the University of Tennessee. Lecture subjects include Bubbles/Deflation and Chaos.

Series 4: Publications, 1970-2013, undated. Boxes 7-16

This series contains articles and books. Of note is *The Journal of Economic Asymmetries* for which Malliaris serves as an editor as well as published books including *Differential Equations, Stability and Chaos in Dynamic Economics*, *New Perspectives on Asset Price Bubbles: Theory, Evidence, and Policy*, and two books about Options Markets. Some articles are in Greek.

Series 4A: Books, 1976-2012, Boxes 7-12

Contains published books as well as some drafts including *Differential Equations, Stability and Chaos in Dynamic Economics*, *New Perspectives on Asset Price Bubbles: Theory, Evidence, and Policy* and *The Journal of Economic Asymmetries* for which he was an editor.

Series 4B: Articles, 1970-2013, Boxes 12-16

Contains several published articles on subjects including Asset Bubbles, the European Union, Greece, Trade agreements, Economic Futures, Inflation, and Oil Markets. Some articles are published in Greek.

Series 5: Conferences, 1977-2015, Boxes 16-23

Contains materials related to conferences Malliaris presented at or attended including presentation notes, conference programs and correspondence with conference organizers. The conferences include Allied Social Sciences Association, The Athenian Policy Forum, Illinois Economic Association, Euro Working Group, Midwest Finance Association, Multinational Finance Society, North American Economic and Finance and Western Economic Association. The series includes Greek and German publications.

Series 6: MBA Program Books, 1988-1998, undated. Box 23

This series contains books for the Graduate School of Business MBA program at Loyola University Chicago. Two program books are from years when Malliaris served as Associate Dean and Director of The Graduate School of Business and on The Dean's Advisory Committee. The books include information about course offerings, instructors and the Graduate School of Business.

Series 7: School of Business Annual Reports, 1978-2009, Boxes 23-24

Contains annual reports for the Graduate School of Business and School of Business Administration. Reports include overviews of programs, student enrollment numbers and graduation numbers, information on courses taught by the faculty, student's previous institutions, and employment placement.

Series 8: Photographs, 1981, undated Box 24

This series contains photographs from a conference held in Greece as well as untitled and undated trip photographs.

Series 9: Restricted, 1989-2013, Boxes 25-26

Contains student evaluations of courses, evaluations from conferences, financial records for the Athens program, a contract to publish an article, student grades, and faculty assessments from his time as the Mullady chair.
